This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child's family; any extraordinary or pertinent information concerning the circumstances of the child's death; whether the child or the child's family received assistance, care or services from the social services district prior to the child's death; any action or further investigation undertaken by OCFS or the social services district since the child's death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child's household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child's siblings or other children in the household.**

OCFS' review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS' assessment and the performance of these agencies.

Presenting Information

The SCR registered two reports regarding the SC's death. The reports alleged that on 4/16/19, the one-month-old SC was bleeding from the mouth and coughing blood but the mother delayed seeking medical attention. The report stated the SC died enroute to the hospital. The SC was in the care of the mother and the father was at work. The whereabouts of the siblings were unknown.

Executive Summary

The SC was a month old when she died on 4/16/19. Due to religious reasons no autopsy was completed. The ME conducted an external examination and listed the cause and manner of death as undetermined.

On 4/16/19 and 4/19/19, the SCR registered two reports regarding the death of the SC. The allegations of the reports were DOA/FATL, LMC and IG of the SC by the mother.

According to the mother, on 4/16/19 she was home alone with the three children and the father was at work. The mother reported that at 12:00 P.M., she found the SC in her crib unresponsive and went to get help from a neighbor. She then called the father and he in turn called 911. EMS arrived at the home and transported the SC to the hospital where she was pronounced dead.

ACS contacted the medical staff and the ME and learned there were no signs of abuse or neglect. The NYPD indicated there was no suspicions of the parents regarding the circumstances of the SC's death.

ACS initiated the investigation timely and determined the siblings were safe in the care of their parents. ACS completed an initial home assessment and found there were provisions for the children and no safety concerns. ACS also made relevant collateral contacts with the children's pediatrician, neighbors and family members and there were no concerns about the care the parents provided for the children.

On 8/9/19, ACS unsubstantiated the allegations of the report based on the cause and manner of death determined by the ME and the ER physician who stated a delay getting the SC medical care did not cause the SC's death. In addition, the SC had no marks or bruises or any signs of trauma.

LDSS Response

ACS initiated the investigation timely and contacted the hospital attending physician who reported the SC arrived at the ER with EMS and a neighbor at 1:19 P.M. The medical staff continued resuscitation efforts to no avail, and the SC was pronounced dead at 1:41 P.M. the parents arrived at the hospital at 2:30 P.M.

According to the mother, on 4/16/19 she breastfed the SC at approximately 6:00 A.M. and placed the SC to sleep in her crib and she also went back to sleep. The mother said she awoke at 10:00 A.M. and noticed the SC was still asleep, and she began to do chores in the home. The mother said she checked the SC at 11:00 A.M. and found the SC asleep. However, when she checked the SC at 12:00 P.M., she noticed the SC had regurgitated, there was blood in the SC's mouth and coming out of the SC's right nostril. The mother said the SC had been placed to sleep on her back as usual. The mother said she was scared and called a neighbor, but got her voice mail then ran over to the neighbor's apartment. The mother she left the apartment for a "quick minute" leaving the siblings behind. The neighbor returned to the apartment with her and then she called the father who was at work and he in turn called 911. The mother said the neighbor went with the SC in the ambulance because the SC was rushed out the home and the mother was not properly dressed. The mother said she received a call from the hospital letting her know the SC's location.

The mother reported that on 3/22/19, prior to the SC's death, she had taken the SC to the ER at Bronx Lebanon Hospital because the SC was regurgitating and having difficulty breathing. The mother indicated she had taken the SC to the hospital twice with breathing difficulties.

The father stated that on 4/16/19, he awakened, prayed with the mother, and got ready to go to work. The father said the SC was awake in her playpen and had no signs of distress when he left the home at 6:00 A.M. The father stated mother called him at 12:54 P.M. in panic saying the SC was "gone" and asking him to "do something." The father said he called 911 at 12:55 P.M. and then he called the mother back at 12:57 P.M. to alert her that an ambulance was on the way. The father said he contacted the PGGU and immediately left his job. The father said the PGGU went to the wrong hospital and he went home to pick up the mother. According to the father, there was nothing unusual about the mother's behavior and she was always very good with the care of the children.

The neighbor corroborated the parents' accounts. The neighbor added when she arrived at the home, she saw the SC was in the crib lying on her back with blood coming from the SC's nose and milk coming from her mouth. The neighbor said she put a blanket on the SC and told the mother to call 911. The neighbor said she went in the ambulance with the SC and the mother remained with the siblings. The neighbor said she waited at the hospital until the parents arrived at 2:40 P.M.

After the SC's death, the PGM came from out of state to temporarily assist with the care of the children. ACS offered the family PPRS, but they declined. ACS also provided a daycare voucher for siblings; however, at the time of the determination the parents had not followed up with childcare assistance.



On 8/9/19, ACS unfounded the report.
