This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

An SCR report alleged that on 4/27/19, the mother was driven to the hospital by a neighbor at 9:30 AM, because she had abdominal pain. The mother waited in in the Emergency Room for some time before the doctor saw her. During the medical exam it was realized the mother had given birth and the baby was inside her sweat pants. The baby had a big laceration on his neck. The laceration had to be taped so the mother could hold the baby. The mother denied knowing that she was pregnant. The mother felt pain in her stomach, then she saw the baby coming out. The mother pulled the baby out and asked her neighbor to drive her to the hospital.

Executive Summary

This fatality report concerns a child that was stillborn on 4/27/19. Suffolk County Department of Social Services (SCDSS) received an SCR report on the same day, regarding the death of a pre-term infant. On 4/27/19, the mother woke at 6:00 AM experiencing discomfort which she believed was due to her menstrual cycle. The mother began to deliver the child but was unable to complete the delivery. The mother panicked and contacted her boyfriend (the father) to take her to the hospital. While in the waiting area of the emergency room at the hospital the mother miscarried the fetus, and was taken into a delivery room. The mother was informed by medical staff the infant was deceased upon delivery.

SCDSS assessed the safety of the 13-year-old maternal aunt who lived in the home and there were no noted safety concerns for her care. There were no surviving siblings.

SCDSS spoke with the doctor who delivered the infant at the hospital and the medical examiner. The doctor told SCDSS the infant was at about 23-24 weeks gestation and was delivered stillborn. The doctor explained the infant's skin is so thin at this gestational stage, that is why the neck appeared to have had a laceration. The medical examiner stated this was a partial delivery and the infant was stuck in the birth canal. The medical examiner said the infant was stillborn and there was no foul play. Law enforcement investigated the fatality and concluded their investigation, finding no criminality involved in the death of the infant.

SCDSS completed all safety assessments and required reports accurately and on time. SCDSS obtained medical and law enforcement records and interviewed family members. There were no noted concerns about the care of the 13-year-old aunt by the maternal grandmother.

SCDSS unsubstantiated the allegations of DOA/fatality and inadequate guardianship against the mother for the infant. The death of the infant was a fetal demise due to miscarriage. SCDSS offered referrals for bereavement services to the family but they declined. The mother and father were attending and receiving counsel from their church at the time of the case determination. The case was unfounded and closed.

LDSS Response



On 4/27/19, SCDSS received the fatality report from the SCR. SCDSS coordinated with law enforcement, completed a CPS history check, spoke with the medical examiner’s office and notified the district attorney’s office of the death. The 13-year-old aunt was assessed and there were no noted safety concerns. There were no surviving siblings.

On 4/27/19, SCDSS interviewed the mother, the 13-year-old aunt and the father about the events of that morning and their statements were consistent. The mother told SCDSS that she woke at 6:00 AM with severe stomach pain and asked the 13-year-old aunt to get her some pads as she thought she was experiencing menstrual cramps. The mother unexpectedly went into labor and was unable to complete delivery of the infant. The mother said she started to panic and called the maternal grandmother at work, but her phone dropped the call. The mother then asked the aunt to call her boyfriend (the father) at work to take her to the hospital as she was in severe pain. The mother said the father transported her to the hospital. The mother said she told the father that she thought she was having a baby. They arrived at the emergency room and the mother was brought into a delivery room where she was told the infant was deceased upon delivery.

SCDSS assessed the safety of 13-year-old aunt, spoke with the paternal grandmother and there were no noted concerns for her care. SCDSS spoke with all family members and no one was aware the mother was pregnant. The mother said she was not aware she was pregnant as she had bleeding a month before. The mother did not realize initially what was happening to her that morning. The father of the infant was interviewed and he was unaware the mother was pregnant.

SCDSS offered the mother, the father, maternal grandmother and the 13-year-old maternal aunt referrals for bereavement services. The mother denied drug/alcohol misuse.

SCDSS obtained information from law enforcement, the medical examiner, attending physician and medical records from the hospital about the fetal demise of the infant. SCDSS obtained school records for the mother and the 13-year-old aunt. SCDSS spoke with the aunt’s school and they reported no concerns for the aunt. SCDSS conducted follow up home visits and offered services to the family but the family declined. The mother had the support of her family, the father and her church.
